Effective July 1, 2023, the School Board of Orange County has approved an amendment to consolidate the Innovation Montessori High School Charter Contract into the Innovation Montessori Ocoee Charter School Contract to create one charter contract for a K-12 charter school known as Innovation Montessori Ocoee (the "Consolidated School"), which will expire on June 30, 2031 (the "Consolidation Amendment"). On or about April 18, 2023, the School Approval Committee of the Florida Department of Education approved the school number for the Consolidated School beginning for the 2023-24 school year (fiscal year beginning July 1, 2023) and for the school number for Innovation Montessori High School to be closed out as of the end of the 2022-23 school year (fiscal year ending June 30, 2023). No other changes were made. A copy of the Consolidation Amendment is attached to this Notice.

THE SCHOOL BOARD OF ORANGE COUNTY, FLORIDA CHARTER AMENDMENT FOR INNOVATION MONTESSORI OCOEE

I. GENERAL PROVISIONS

This is a charter amendment made and entered into this 14th day of February 2023, by and between THE SCHOOL BOARD OF ORANGE COUNTY, FLORIDA (hereinafter referred to as the "Sponsor") and INNOVATION MONTESSORI OCOEE, (hereinafter referred to as the "School"), a not for profit organization organized under the laws of the State of Florida.

WHEREAS, Sponsor is desirous of supporting quality charter schools pursuant to S. 1002.33, Florida Statutes, that are designed to and will enhance the education of Orange County Public School students; and

WHEREAS, School is desirous of maintaining and operating a charter school pursuant to S. 1002.33, Florida Statutes, to enhance the education of those Orange County students who choose to attend the School;

WHEREAS, School shall be part of the state's program of public education and fully recognized as a public school; and

WHEREAS, pursuant to §1002.33(7)(d) permits modification of charter contracts, including "consolidation of multiple charters into a single charter if the charters are operated under the same governing board, regardless of the renewal cycle";

NOW, THEREFORE, pursuant to S. 1002.33, Florida Statutes, Sponsor and School do hereby agree that the original application and contract shall be amended and shall constitute the amended School's Charter with agreement to the following:

1. Scope and Focus: Consolidation and Name Change

The Charter contracts for Innovation Montessori Ocoee (MSID# 0172) and Innovation Montessori High School-Ocoee (MSID# 0272) are consolidated under one charter contract, Innovation Montessori Ocoee. The consolidation shall include the name change of the charter school to Innovation Montessori Ocoee and will expire on June 30, 2031.

2. Section 3: Students

Innovation Montessori Ocoee charter will serve students in grades K through 12th with an enrollment capacity not to exceed 1650 students.

3. Supremacy of Original Contract

BACKGROUND:

Innovation Montessori Ocoee Charter School (K-8) was approved to open in August of 2011 and was subsequently renewed in February 2016 with a (15) fifteen-year contract by unanimous vote of the Orange County School Board. Innovation Montessori High School-Ocoee received a charter contract beginning on July 1, 2019, for five (5) years. The governing board for Innovation Montessori Ocoee and Innovation Montessori High School-Ocoee has requested an amendment to their contracts. The amendment will reflect a consolidation of the schools under the Innovation Montessori Ocoee charter contract. The name of the school shall be Innovation Montessori Ocoee and the charter contract will expire on June 30, 2031.

Pursuant to §1002.33(7)(d), FI. Stat., the two charter contracts may be consolidated into one as both schools are operated by the same governing board.

Innovation Montessori Ocoee and Innovation Montessori High School will have a combined enrollment capacity of 1650. Pursuant to §1002.33(7)(d), Fi. Stat. and §1002.33(10)(e), Fl. Stat., this consolidation and enrollment increase may be afforded to Innovation Montessori Ocoee Charter School with approval of the Sponsor, the Orange County School Board.
